- Dogs younger than three months of age can be licensed without having a rabies vaccination.
- Sign and date the application before sending to the office.

FREQUENTLY ASKED QUESTIONS

What should I do if my dog is lost or I find a lost dog?

If the dog has a current license on it, call our office or perform a search for the dog through our website at doglicense.franklincountyohio.gov.

What should I do if I move?

If you move within Franklin County, call our office or visit our website to update your information.

If you move outside of Franklin County, call our office for licensing information.

We will honor other current Ohio county licenses until expired.

Can I transfer a license if I sell or give my dog away?

Yes, you can. Call our office or visit our website to complete a transfer form.

- How do I replace a lost license? You can request a duplicate license from our office.
- How do I replace a rabies tag? Contact Franklin County Public Health at (614) 525-3160 for a replacement rabies tag.

DOG FACTS

All dogs older than three months of age:

- Must be licensed
- Must have their licenses renewed each year
- Must have a rabies vaccination

The dog license renewal period runs from December 1 through March 31 each year. After March 31, the fees for dog licensing are doubled.

Dog licenses can be purchased for a oneyear period, a three-year period, or a lifetime period.

Dogs younger than nine months old that are not spayed or neutered are not eligible for a multi-year license.

Licenses are discounted if one of the following conditions apply:

- Your dog is spayed or neutered
- Your dog is under 9 months old
- Your dog is being bred for sale/show
- Your dog is intended for hunting

Unlicensed dogs are held for only three days when taken to the shelter, whereas dogs with licenses are held up to 14 days.
